

# MEMPHIS INTERNATIONAL AIRPORT – RESTROOM WAITING AREAS (DESIGN ONLY) | REQUEST FOR QUALIFICATIONS

Release Date: Monday, February 24, 2020
Artist Design Fees: \$15,000 (per three installations)
Deadline: Monday, April 6, 2020 at 11:59 pm
Eligibility: Any artist currently living and working in Memphis, TN or Shelby County Artists are invited to apply as a team if desired.

# BACKGROUND

The Memphis International Airport is being reimagined as the facility undergoes an important renovation. A dramatic enhancement of the B concourse is currently underway, and will be completed by April 2021. Memphis's aviation industry dates back to 1927, when city Mayor Watkins Overton formed the Municipal Airport Planning Commission. The Commission broke ground on a 200-acre tract of open countryside seven miles from Downtown, and the Memphis Municipal Airport opened for regular passenger and mail service in 1929. The current terminal, a modern design by architect Roy P. Harrover, was dedicated in 1963. The growing facility changed its name to Memphis International Airport, and in 1974, the building expanded into its current configuration.


The renovated concourse B pays homage to Harrover's mid-century modern design, with sweeping vaulted ceilings and minimalist furniture, along with updates like larger windows, natural wood accent walls, and a contemporary color palette. This modernization will provide visitors and Memphians alike with an inviting experience, and a taste of what Memphis has to offer.

As part of the overall reimagining of the airport, \$1.5 million has been allocated to produce new site-specific public art projects at key locations throughout the facility. These projects include a large suspended sculpture, a permanent exhibition of 2D work by local artists, and three art glass installations.

## SITE SPECIFICS

The renovated concourse features three restroom facilities, each consisting of a men's room and a women's room adjoined by a central waiting area. An approximately 9' x 13' translucent glass privacy wall obscures the windows in each restroom, and an approximately 9' x 27' translucent glass wall obscures the windows in the adjoining waiting area. These glass installations may be thought of as three separate sections, or as one continuous 9' x 53' wall. The glass will be divided into panes to accommodate the art glass process, and aligned with the existing window mullions in the new concourse.





# SCOPE OF WORK

UrbanArt Commission (UAC) is partnering with the Memphis Shelby County Airport Authority (MSCAA) to commission glass artworks for three waiting areas and restrooms in the new concourse. Selected artists will be commissioned to create designs only, which will be printed with ceramic ink on architectural glass panels. UAC will contract directly with a glass studio to fabricate the pieces and an installation team. The studio will collaborate closely with the selected artists to translate their commissioned artwork onto glass. The selection committee expresses an interest in a public art piece that will:

- Provide travellers with an experience of the diverse voices and visions of Memphis' contemporary artists, designers, photographers, painters, printmakers and creatives
- Feature designs that will be meaningful and engaging for airport patrons, both now and in the future
- Respond to the aesthetic of the reinvented concourse, which features warm tones and natural wood, minimalist contemporary furniture, vaulted parabolic ceilings, and natural light from long curtain-wall windows

The selection committee will select nine finalists for the three installations based on their portfolio, application materials, professional qualifications, and demonstrated ability to meet deadlines. The three commissioned artists will be selected based on the strength of their proposals, which will be presented to the selection committee.

UAC is committed to equity and inclusion in our work, both in the artists and organizations supported through the development of public art. UAC is especially interested in applications from artists who have not previously received public art commissions. People of color, differently-abled persons, indigenous peoples, LGBTQ+, seniors, and women are strongly encouraged to apply.

### **DESIGN FEES**

Three artists will receive \$15,000 each for design fees for commissioned artwork.

#### FINALIST REQUIREMENTS

Each finalist will be asked to prepare a schematic design or mockup, followed by a presentation to the selection committee. Each finalist will receive a \$1,500 honorarium for an original design developed specifically for the site.

#### GUIDELINES

• Completed application form

- A typed letter explaining your interest in the project and your general approach/concept to its design and production. *Please do not submit design proposals at this point.*
- Up to 20 images of past work including title of work, date, medium, budget and project partners, if any.
- Résumé or CV, not to exceed 2 pages.
- List of three professional references, including current phone and email.
- To apply to an open Request for Qualifications (RFQ) or Request for Proposals (RFP), go to <u>uacmem.org/calls-to-artists</u>. Click on the opportunity that you are interested in to view more details.
- 2. Clicking on the Submit button will redirect you to our Submittable page, which contains all of our current open opportunities. Click the Submit button next to the opportunity that you wish to apply for, or if you are already within an opportunity, scroll down to the Create your account / Have an account? Sign in form.
- 3. If you already have a Submittable account, click the Have an account? Sign in tab to sign in to your account. If you don't remember your password, use the Forgot? link on the login form.
