Create a cultural plan through inclusive, accessible, and equitable county-wide engagement that will maintain, grow, and sustain the arts and culture sector in Durham for the next decade and beyond.

We envision a thriving arts and culture sector in Durham. We celebrate the cultural practices, histories, institutions, and individuals that define Durham's art and culture sector. We work towards the preservation of Durham's cultural heritage, the protection of cultural assets and the equitable distribution of resources to artists, cultural workers, and organizations in the arts and culture sector for the benefit of all Durham residents. We welcome new stories and strive to embrace and extend Durham's cultural community to all residents and visitors of Durham.

Planning & Engagement

Phase I

In the first phase of the planning process, partners will research, collect data, conduct focus groups and interviews, and lanuch initial engagement.

Phase II

Robust, interactive & creative community engagement, funding analysis, and operating structures will be explored.

Phase III

Goals and strategies will be developed and shared for feedback, with public presentations. Durham County Commissioners and City Council will review the proposed plan for adoption.

History

In 2004 Durham Cultural Master Plan was approved by City Council and the Durham County Board of Commissioners.

Since 2021, the Durham Cultural Advisory Board has engaged artists and cultural workers regarding the challenges and opportunities they face.

In October 2022, Durham City Council and Durham County Board of Commissioners jointly supported the development of a new cultural plan. The Durham Cultural Roadmap is needed to support and amplify the role of Durham's cultural community for the benefit of all residents and visitors.

The Durham Cultural Roadmap Phase I Report, completed in late April 2024 by AMS Planning and Research, addresses potential priorities, themes, and issues identified through community engagement.



As Phase II of the Durham Cultural Roadmap begins, the City, in partnership with County, is soliciting a Consultant or Consultant Team to provide comprehensive cultural planning services. The services should include robust and equitable engagement, review and collection of data, Phase I Report assessment, funding analysis, plan recommendations, and strategies for implementation throughout Phase II and Phase III of the plan.

The <u>Cultural Roadmap Planning Group</u> was formed to broaden the City and County's capacity to hear from and respond to the community during the planning process.
