## 1.0 PROJECT INFORMATION:

1.1 Hillsborough County (County) is interested in receiving submissions from artists demonstrating their ability to provide completely realized artworks dealing with topography. The community wishes to tie their park to both spirituality and science through a work which promotes gathering and awareness of the passage of time. Portions of the work may promote community and youth involvement through an annual painting program. The piece should require very low maintenance and the minimal use of plantings to achieve the artist's intent. The 25 A. site currently includes a 14,000 S.F. library, community garden, and walking trail. The selected artist(s) will be responsible for the design, fabrication, and installation of the permanent artwork.

# 2.0 SUBMITTAL INSTRUCTIONS:

- 2.1 Artists who wish to be considered for these projects must submit the following materials electronically. Ensure that all files sent electronically have been scanned by up-to-date virus scanning software. Files with detected viruses will be destroyed and will not be considered. All images and documents must be accessible in the MS Windows environment. Incomplete submissions will not be considered. The following documents are required:
  - 1. A current professional resume of no more than 2 pages for each submitting artist.
  - 2. No more than six (6) image files of recent work. Image files must be properly labeled each with artist's last name and a number (1-6) assigned per image list. (e.g.:smith\_1.jpg, smith\_2.jpg). Names should NOT appear directly on any image.
  - 3. Image ID sheet, explaining the content and context of each image.
- 2.2 Instructions for electronic submission:

- 2.3.1 Proposals will be reviewed by the Site Advisory Committee and the County's Public Art Committee.
- The intent of the review is to short list a group of up to three artists to provide more specific proposals relating to 2.3.2 possible themes, character, and materiality of proposed installation(s). The County may contract with only one artist or artists group to fulfill the requirements of the listed project.
- 2.3.3 Hillsborough County does not guarantee that any commissions will result from this call.

## 3.0 ESTIMATED BUDGET, SCHEDULE AND SELECTION PROCESS:

- 3.1 Estimated Budget For the Project: \$80,000 - \$85,000.
